The American **Real Estate** and Urban **Economics** Association (AREUEA) invite you to submit a paper for AREUEA's 48th Annual Conference; held in conjunction with the Allied Social Science Association (ASSA) meetings. This annual conference will be held January 4-6, 2013 in San Diego, California.

The 48th Annual AREUEA Conference will consist of twenty-two paper and/or panel sessions. Other features include a special program for doctoral students and social networking events.

The topical focus of the conference sessions will include theoretical, empirical, and policy research in real estate economics, real estate finance, and urban economics.

All papers **must be** submitted via the AREUEA website at: <https://www.areuea.org/members/papers/>.

Additionally:

1. At least one author must be a member of AREUEA in order to submit the paper and present at the conference (AREUEA member user id & password are required to submit a paper).
2. The paper cannot be submitted to or under consideration for inclusion with any other ASSA participating organization.
3. The contact author will be notified no later than June 15 of acceptance or rejection of the submission.
4. Submit your completed manuscript with an abstract or a well-developed abstract, no later than April 1, 2012 (*priority is given to completed manuscripts*). Papers and abstracts should include a list of references that is as complete as possible.
5. Should your paper be accepted for the program, you must provide your assigned chair and session discussant a copy of your completed paper no later than December 1, 2012.
6. You must provide the following information for submission:
 - Title of paper;
 - Two or three key words indicating the topic;
 - Corresponding author;
 - Institutional affiliation;
 - Complete address, telephone, facsimile, and email address,
(*Contact & institutional affiliation information is also requested for each additional author.*)
7. To help prospective AREUEA Annual Meeting participants to find the papers and sessions of their interest, the completed papers accepted by the program will be available online at the AREUEA website (unless otherwise requested by the author at the time of submission).

Papers must be submitted no later than:

April 1, 2012

to be considered for the San Diego Conference.
