Job Summary Statement:	<p>The UCLA Ziman Center for Real Estate and the UCLA Anderson Forecast, both research centers at the UCLA Anderson School of Management, are seeking a full-time staff research economist. The position will lead both Centers' activities on the analysis of federal, state and local policy impacting real estate and the built environment, broadly applied across disciplines, with an emphasis on housing markets, especially affordable housing. The position will also conduct macro-economic forecasting of residential and commercial real estate markets in California and its regions. The successful candidate will conduct economic research, review and analyze policy, present findings, and participate more broadly in the activities of the Ziman Center, Forecast, and the Anderson School. The position requires production of high-level analysis for presentation at conferences and in publications to a diverse audience including academicians, business executives and government policymakers. Excellent written and oral communication skills are essential, as well as the ability to work with frequent deadlines.</p>
